Re: Sandy Boys, LLC and Sony Music Entertainment: Further Amendment to Letter of Direction

Dear Gentlepersons:

Reference is hereby made to the profit share agreement by and between Sony Music Entertainment (“you” or “Sony”) and Sandy Boys, LLC (“Company”) dated as of July 28th, 2018 [CR 18- A.1], relating to the recording services of Dominic Fike, as such agreement may have been modified and amended from time to time (the “Agreement”). All capitalized terms used but not defined herein shall have the meanings given to them in the Agreement.

Reference is further hereby made to that certain letter of direction dated as of August 2, 2018 (the “Letter of Direction”) regarding the initial Profit Advance as set forth in paragraph 2A.01(a)(1)(i) the Agreement. A copy of such Letter of Direction is attached hereto as Exhibit A. This letter shall serve as notice that Company hereby revokes the Letter of Direction.

Company hereby further modifies its instructions to direct you to pay: \$12,500 to Sedlmayr & Associates, P.C., and the balance in the amount of \$237,500 to the law firm of Russ, August & Kabat, LLP upon commencement of recording of the Third Album during the Third Contract Period in accordance with Paragraph 2A.01(c)(2) of the Agreement.


